- April 1, 2019, 'The Singapore Food Agency'
- Reactive nature of government: Minister clause
- Existence of business with comparable work?

Legislation Neighbours Malaysia and Indonsia

- In both countries, a bit more extensive regulation
- Pre-existing regulations on foodbyproducts in animal feed is non-existent in Malaysia and government: reactive character and will judge on a case-by-case basis
- Indonesia: more extensive rules and regulation, ministry of Agriculture, feed needs to be registered
- Generally speaking, Dutch legislation is way more

Prime examples Japan & South-Korea

Japan: law that prioritizes creation of ecofeed **52%** is recovered into animal feed 93% pre consumer industry ...16% post consumer industry

South-Korea: **42.6%** of total food waste processed into animal feed



Livestock - Swine


"Pork is the red meat of choice for many Singaporeans." (AVA 2017)

Swine slaughtered in 2017 (number of heads)




Livestock - Poultry

Supply – The food industry

Food byproducts are products besides the main food products, resulting from food production or food procession, unsuitable or undesirable for human consumption

- Dense food industry
 - 233 manufacturers
- Two types of byproducts:
 - Pre-consumer byproducts (industry- and retail level)
 - Post-consumer byproducts (household, restaurant, and catering level)
- Legislation & Food Safety

Supply – Estimation of industrial byproducts

Food by-products	Estimated Quantity	Unit of measure
Cacoa shell powder	790.5	tonnes
Fish byproducts	38,980	tonnes
Malt spent grains	378.3	1000 MT
Palm oil sludge	2.1	1000 MT
Soybean byproducts	86.2	1000 MT
Trimmings of raw noodles	2920	Tonnes
Wheat byproducts	67.7	1000 MT
